What is a TTS?

A Tobacco Treatment Specialist (TTS) is a professional who possesses the skills, knowledge and training to provide effective, evidence-based interventions for tobacco dependence for all forms of tobacco and nicotine use.

The Association for the Treatment of Tobacco Use and Dependence (ATTUD) has established a set of core competencies for Tobacco Treatment Specialists. The competencies serve as a measure to provide best practices for effective treatment of tobacco use.

Who Should Attend?

The target audience for the training include the following: Physicians, advance practice providers, mental health counselors, addiction counselors, nurses, social workers, pharmacists, respiratory therapists, peer recovery coaches, and other health care professionals who work with tobacco and nicotine users.

Training Overview

The TTS Core Training is an intensive 4-day, in-person, evidence-based training program. The training is designed for persons who work with tobacco/nicotine dependent clients or deliver tobacco treatment services within a healthcare or community setting.

You'll Be Able To:

- Understand the biological, psychological, and social determinants of nicotine addiction to better treat tobacco users.
- Explore role of a TTS.
- Review and demonstrate motivational interviewing strategies and skills.
- Apply evidence-based pharmacological treatment approaches.
- Build skills to enhance behavioral interventions.
- Address treatment planning and relapse prevention for tobacco treatment.

Training Prerequisite:

- Participants must successfully complete the [UMass Basic Skills for Working with Smokers online course](#) before attending the training. **Please note:** there is a fee for this online course payable to the University of Massachusetts when registering.
- Participants must be tobacco-free for 6 months prior to attending the training.

Registration:

Registration cost is \$475 per person and includes training materials, continuing education contact hours, and breakfast and lunch for all four training days. Space is limited. Register online by [clicking here](#).

The national certificate program was created to standardize and unify tobacco competencies, knowledge, and skills on a national level and provides national, unified recognition of professionals who obtain this prestigious certificate. By obtaining the NCTTP, tobacco use professionals are demonstrating to employers, third-party payers, and clients their advanced education in evidence-based tobacco competencies, skills, and practice.
